City Council Meeting Minutes

The City Council of Annetta met in a regularly scheduled meeting on Thursday, September 21, 2017, at 7:00 p.m. in the Annetta Town Hall at 450 Thunder Head Lane to consider the following agenda:

- I. Call to order. Mayor Bruce Pinckard called the meeting to order at 7:00 p.m.
- II. Pledge of Allegiance/Invocation of Prayer. Councilman Mark Wohl led the pledge and Mayor Bruce Pinckard gave the invocation.
- III. Roll call/Quorum check. A quorum check revealed that Mayor Bruce Pinckard, Councilmembers Kent Stasey, Mark Wohl, Shane Mudge and Rico Remigio were all present. Councilmember Danny Coffman was absent. Also present, Jamee Long, City Secretary, and Dennis Thompson, Director of Operations and Planning.
- **IV. Public Comments:** Jeff Kinzler addressed the council regarding his unusually high water bill. Mayor Bruce Pinckard discussed the Town's water tiers and consumption.
- V. Consent Items: Reports from City Staff and Commissions or Committees:
 - a. Consider the approval of Minutes from the Regular City Council Meeting on August 17, 2017.
 - b. Financial Report.
 - c. Public Works Report. Councilman Stasey moved to accept the August 17, 2017 Regular City Council Minutes, Financial Report and Public Works Report, Councilman Remigio seconded the motion, with all aye. Motion passed unanimously.
 - d. CCPD Report. Jaime Saenz, CCPD Coordinator, discussed the progress of the Annetta Community Crime Program, Block Party Event and CCPD Budget. He stated the next CCPD meeting will be held on October 5, 2017, and the Mayor suggested this CCPD meeting be posted as a workshop or planning meeting. Councilman Stasey moved to accept the CCPD Report, Councilman Mudge seconded the motion, with all aye. Motion passed unanimously.

VI. New Business:

- a. **Public hearing on the Town of Annetta FY 2017-18 Budget.** The public hearing began at 7:18 p.m. and closed at 7:19 p.m. No public comments.

Motion passed unanimously. Lengthy discussion regarding the Town's water system, billing, water consumption, meter readings and cost of living in Annetta.

- c. Discussion and Action: Consider amending the Town of Annetta Purchasing Policy by adding the Telephone Quote Sheet Form.
