

The property is located at 1515 Wallis Road.
- b. **Discussion and Consider:** Conduct a public hearing and consider a request from Anne Mullins for a Special Exception to Section 8.10.B.10 of the Town of Annetta Zoning Ordinance 215 to allow garage doors on any size accessory structure to face the right-of-way with additional landscaping, exterior materials or colors and ornamental features to ensure compatibility with the neighborhood. The property is located at 1515 Wallis Road.
