
- a. **Discussion and Consider:** Conduct a public hearing and consider a request from Jeremiah Adkins for a Special Exception from Section 8.10.B.2.c of Zoning Ordinance 215 to allow for an 800 square foot accessory structure that exceeds the allowed square footage. The property is located at 222 Deer Creek Drive.
- b. **Discussion and Consider:** Conduct a public hearing and consider a request from Jeremiah Adkins for a Special Exception to Section 8.10.B.10 of the Town of Annetta Zoning Ordinance 215 to allow garage doors on any size accessory structure to face the right-of-way with additional landscaping, exterior materials or colors and ornamental features to ensure compatibility with the neighborhood. The property is located at 222 Deer Creek Drive.
- c. **Discussion and Consider:** Conduct a public hearing and consider a request from Jeremiah Adkins for a Special Exception from Section 8.10.A of Zoning Ordinance 215 to allow for an accessory building to be placed in the side yard instead of the rear of the lot.
