## ORDINANCE #16

## FRANCHISE FOR HAULING GARBAGE AND REFUSE - CITY OF ANNETTA

ESTES SERVICE COMPANY hereby proposes to haul all garbage and refuse for the City of Annetta under the following rules and conditions:

- 1. Estes to furnish all equipment and personnel to haul and dispose of all garbage on a regular schedule basis.
- Estes to maintain an office and phone during regular business hours to receive and service complaints and requests of citizens of Annetta.
- 3. Estes to charge \$7.00 per month for once a week service to each single family residence. Business and Commercial rates to be negotiated between customer and Estes.
- 4. Rates are to be adjusted each January by renegotiation between Estes and the City of Annetta.
- 5. It is further agreed that Estes will have the option of increasing its fee in proportion to cost of living increases as reflected by the cost of living index prepared by the U. S. Government.

## ANNETTA hereby agrees:

- Each Annetta household to have garbage properly prepared in a regulation container or bags and placed on end of driveway or curb closest to street on day of pick up, not to exceed (5) five such containers or bags.
- Trash and rubbish such as brick, concrete, lumber, dirt, old furniture, auto parts, dead trees and other such heavy, bulky material is not included in this agreement.
- 3. Collectors will not be required to pick up any refuse or garbage which does not conform to these requirements.
- 4. Estes will collect their fee directly from each customer.
- Estes to pay City of Annetta (4%) four percent of total fees received.
- Term of this franchise shall be (10) ten years and may be reviewed for a like period.
- 7. Effective date of this franchise will be July 1, 1983.
