ordinance no. 55

AN ORDINANCE REGULATING DISPOSAL AND PLACEMENT OF BUILDING MATERIAL, GARBAGE AND TRASH RELATING SOLELY TO CONSTRUCTION; PRHIBITING THE BURNING OR BURYING OF SUCH MATERIAL WITHIN THE CITY AND REQUIRING THAT EVERY BUILDING SITE HAVE A CONTAINER AND OTHER MEANS OF PREVENTING SUCH MATERIAL FROM BLOWING; PROVIDING A PENALTY AND AUTHORIZING PUBLICATION.

WHEREAS, the City Council desires to promote the health and general welfare of the inhabitants of the City of Annetta through the regulating of the means of handling and disposing of building material and trash relating to construction; NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANNETTA, TEXAS:

- Sec. 1. It shall be the duty of every owner, builder, agent, lessee, carpenter or occupant of any premise in the City to provide and use containers sufficient in number to hold the waste pertaining to construction on said property of new construction.
- Sec. 2. No person, firm or corporation shall burn or bury such waste pertaining to construction within the corporate limits of the City.
- Sec. 3. Holders of building permits within the City are required, as a condition of maintaining such permit, to maintain adequate waste disposal equipment or fencing on site so as to prevent the blowing of trash from the building site onto adjacent property.
- Sec. 5. Any person, firm or corporation violating any provision of this ordinance or failing to perform the duties as set forth herein shall be deemed guilty of a misdemeanor and upon final conviction thereof fined in an amount not to exceed Two Thousand Dollars (\$2,000.00). Each and every day any such violation shall continue shall constitute a separate offense and punishable hereunder.
- Sec. 6. The City Secretary is hereby authorized and directed to cause publication of the descriptive caption and penalty clauses of this ordinance as an alternative method od publication as provided by law.

Sec. 7. The terms, phrases, words and sections of this ordinance shall be deemed severable and if any such phrase, clause, sentence, words or sections of this ordinance shall be declared invalid by the final judgement of any court of competent jurisdiction, such invalidity shall not affect any of the remaining portions of this ordinance since the same would have been enacted by the City Council without the incorporation in the ordinance of any such invalid portion had it been aware of its invalidity.
