



Minutes

Town of Annetta City Council Meeting April 19, 2012 7:00 pm

The Town of Annetta met on Thursday April 19, 2012 at 7:00 pm in the City Hall, 1200 Old Annetta Road.

- I. Mayor Pinckard called the meeting to order at 7:01 pm.
- II. A quorum check revealed that Mayor Pinckard, Councilmen Evans, Sheridan, Lunsford, Harris and Patterson were present.
- III. Councilman Evans led the pledge and Councilman Lunsford led the invocation.
- IV. Community Input: Scott McEachron addressed the council regarding the nuisance complaint by T.Zak Johnson. Kathryn Thompson and Traci Fambrough addressed the council regarding the water system improvements.
- V. Consent Items:
 - a. Roads: No report.
 - b. Minutes: Councilman Harris made a motion to approve the minutes from the March 1, 2012 and March 12, 2012 meetings. Councilman Sheridan seconded the motion and it carried unanimously.
 - c. Financial Report: Councilman Sheridan gave the report.
 Councilman Lunsford made a motion to approve the report as read.
 Councilman Harris seconded the motion and it carried unanimously.
