AN ORDIANACE ADOPTING THE BUDGET FOR THE FISCAL YEAR JANUARY 1, 1998 THROUGH DECEMBER 31, 1998, FOR THE CITY OF ANNETTA, TEXAS.

WHEREAS, such public hearing on the budget was duly held and all interested persons given an opportunity to be heard for or against any item therein; NOW THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANNETTA, TEXAS:

Section 1: THAT the budget for the City of Annetta, Texas, for the fiscal period beginning January 1, 1998 and ending December 31, 1998, in words and figures as shown therein, are adopted and approved as filed therewith.

Section 2: THAT the Mayor be and is hereby authorized to make inter-department and inter-fund transfers during the fiscal year as deemed necessary in order to avoid overexpenditure of particular accounts.

Section 3: THAT the Mayor or his designee be and is hereby authorized to invest any funds not needed for current use in any lawful manner. Interest accrued from investments shall be deposited to the interest income account of the funds from which the principal was invested.
