

RESOLUTION NO. 16-01

WHEREAS, the regular election for Town Council of the Town of Annetta, as set forth by the Texas Election Code, is required to be held on May 7, 2016, at which time the voters will elect persons to serve in the positions of Town Council Places 1, 2, 3 and 4; **NOW THEREFORE**,

BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF ANNETTA, TEXAS:

Section 1: THAT an election is hereby called to elect persons to the positions of Town Council Places 1, 2 and 4 to serve until May of 2018 and Place 3 until May of 2017, or until their successors are duly elected or appointed and qualified. Such election shall be held at 450 Thunderhead Lane, Annetta, Texas, on the 7th day of May, 2016, from 7:00 a.m. until 7:00 p.m.

Section 2: Qualified persons may file as candidates by filing applications in the office of the Town Secretary, 450 Thunder Head Lane, Annetta, Texas, Monday through Friday, from 8:00 a.m. until 5:00 p.m. from January 20, 2016, through February 19, 2016.

Section 3: The Town election precincts for this election shall be the precincts disclosed on Exhibit "A" attached hereto as well as the polling places. The Town will use the same appointed election judges and alternate judges as appointed for the upcoming General Election, which will be held on Saturday, May 7, 2016.

Don Markum is hereby appointed early voting clerk. Early voting shall be at the attached list of locations.

Days and hours for Early Voting by Personal Appearance shall be as follows:

Monday, April 25, 2016	8:00am – 5:00pm
Tuesday, April 26, 2016	7:00am – 7:00pm
Wednesday, April 27, 2016	8:00am – 5:00pm
Thursday, April 28, 2016	7:00am – 7:00pm
Friday, April 29, 2016	8:00am – 5:00pm
Monday, May 2, 2016	8:00am – 5:00pm
Tuesday, May 3, 2016	8:00am – 5:00pm

Applications for early voting by mail shall be delivered to the Early Voting Clerk 1112 Sante Fe Drive, Weatherford, Texas 76086 no later than the close of business on April 26, 2016.

Section 4: The election shall be a joint election with those entities which choose to have a joint election with the Town and shall be conducted by Parker County, which shall designate Election Judges, clerks and Early Voting Clerks., and provide


voting machines. To the extent required by law, those persons designated by Parker County as election officers and clerks are hereby appointed by the Town. The Mayor is hereby authorized to execute a contract with Parker County on behalf of the city for the cost of the election.

Section 5: The election shall be conducted according to the election laws of the State of Texas.
