

ORDINANCE NO. 445

AN ORDINANCE REGULATING PLUMBERS, ELECTRICIANS, AND MECHANICAL CONTRACTORS WHO CONTRACT THEIR SERVICES WITHIN THE TERRITORIAL LIMITS OF THE CITY OF ANNETTA: PROVIDING FOR THEIR ADHERENCE TO PLUMBING, ELECTRICAL, AND MECHANICAL CODES APPROVED BY THE CITY: PROVIDING FOR A SAVINGS CLAUSE: PROVIDING FOR A SEVERABLE CLAUSE: AND TO PRESCRIBE ENFORCEMENT FOR THE PROVISIONS OF THIS ORDINANCE.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ANNETTA, TEXAS that:

SECTION ONE

This Ordinance shall be known and may be cited as "The City of Annetta Plumbers, Electricians, and Mechanical Contractors Ordinance".

SECTION TWO

The Plumbing Contractor be approved by the Texas Board of Plumbing Examiners.

SECTION THREE

The Electrical Contractor be a holder of a certificate of examination qualifying him for the grade level he is seeking and be approved by the Tarrant County Electrical Examining Board.

SECTION FOUR

The Mechanical Contractor be approved by the Texas Department of Labor and Standards Boiler Division Air-conditioning and Refrigeration Licensing Section.

SECTION FIVE

The invalidity of any section, subsection, or provisions of this ordinance hereby adopted shall not invalidate the remaining sections, subsections and portions thereof and if any section, subsection, sentence, clause, phrase, or portion of the Ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the remaining portions hereof.

SECTION SIX

If any person or persons violate this Ordinance, the Building Inspector may institute on behalf of the City of Annetta any appropriate action, suit or proceeding in law or equity to prevent such unlawful use, to restrain, correct or abate such violation, to prevent the use of such premises in any manner prohibited by this Ordinance, or to prevent any illegal act, the conduct of business or use within the territorial limits of the City of Annetta, Texas.

SECTION SEVEN

This Ordinance shall be effective and be in full force and effect immediately upon its passage and publications as by law provided.
